0169 E (i) A Candidate who has passed Due-degree examination in Arts/Science/Commerce or any examination of the Bachelor's Degree (Pass or Honours) Course in Arts/Science/Agri./Commerce or of the shastri Degree Course or of the M.A./M.Sc./M.Com./Acharya Course of the University and desires to improve his performance may be permitted to re-appear at the same examination in the same subject (s)/paper (s) in the immediately following year on the following conditions:

- (i) He shall not re-join a college for the purpose.
- (ii) He shall, as a rule, be examined according to the scheme and syllabus in force.
- (iii) He shall, re-appear in all the theory papers as well as the practical/viva-voce (wherever prescribed). A candidate who had offered dissertation (where prescribed) shall submit a fresh dissertation on a new subject or offer a paper in lieu thereof.
- (iv) His result shall be released only if he obtains more marks in the aggregate than those obtained by him in his previous attempt and thus improves his performance. In case the performance of the candidate does not improve, his earlier performance will stand.
- (v) He shall not be included in the merit list.
- (vi) Only one chance shall be given to a candidate for improvement of performance under this Ordinance.

Detailed discussion about the syllabuses of B.Com, M.Com, B.B.A. and other courses were held. It was pointed out that the UGC has recommended semester scheme in UG Courses also. After detailed deliberations it was unanimously resolved that:

The primary item on the agenda was the discussion and approval of the syllabi for the following courses:

Three/Four-year Bachelor of Commerce (B. Com)

Three/Four-year Bachelor of Commerce (Business Administration)

Three/Four-year Bachelor of Business Administration (BBA)

Master of Tourism Management

Master of Marketing Management

The members engaged in detailed discussions regarding the syllabi for the mentioned courses. It was noted that as per the guidelines of the National Education Policy (NEP) 2020, the University Grants Commission (UGC) has recommended a semester scheme for the Bachelor of Commerce, Bachelor of Commerce (Business Administration), and Bachelor of Business Administration programs.

After thorough deliberation and considering the NEP 2020 recommendations, all the members present unanimously agreed to approve the syllabi for the first and second semesters of the three/four-year Bachelor of Commerce, three/four-year Bachelor of Commerce (Business Administration), and three/four-year Bachelor of Business Administration programs. Copies of the approved syllabi were enclosed with the minutes.

Additionally, the syllabi for the first, second, third, fourth, fifth, and sixth semesters of the Master of Tourism Management and Master of Marketing Management were also approved. Copies of these syllabi were enclosed as well.

It was noted that no changes were made to the syllabi of the Master of Commerce (Business Administration), Master of Commerce (International Business), and Master of Commerce (Human Resource Management) courses in both the semester and annual schemes for non-collegiate students.
