

A meeting of the Board of Studies in History, University of Rajasthan, Jaipur was held on Monday, 19th June, 2017 at 12 noon in the Vice Chancellor Secretariat, University of Rajasthan, Jaipur with the following agenda items :-

1. Preparing the final draft of the syllabus of M. A. History Semester III & Semester IV Examinations to be implemented w. e. f. the academic session 2017-18.
2. Revision in the syllabus of some papers of M. A. History Semester I and Semester II Examinations to be implemented w. e. f. the academic session 2017-18.

The members of the board deliberated upon the above mentioned agenda items and resolved the following:-

Agenda Item No. 1: The Board approved the draft of the syllabus of M. A. History Semester III & Semester IV Examinations, to be implemented w.e.f. the academic session 2017-18. The new syllabus of M. A. History Semester III & Semester IV Examinations, thus agreed upon by the BOS members, is attached herewith in Appendix I. This syllabus is recommended to be implemented w.e.f. the ensuing academic session i.e. 2017-18.

Agenda Item No. 2: The Board recommended revision in the syllabus of some papers of M. A. History Semester I and Semester II Examinations to be implemented w. e. f. the academic session 2017-18. The revised syllabus of the related papers of M. A. History Semester I and Semester II Examinations is enclosed herewith in Appendix II. The syllabus of other papers running in M. A. History Semester I and Semester II Examinations will remain unchanged.



Agenda Item No. 4: The Board discussed the Resolution No. 6 dated 24-03-2017 of the Faculty of Social Science in the light of the letter no. D.O. No. 9-2/2017 (CPP II) dated 31-01-2017 received from Jaspal S. Sandhu, Secretary, University Grants Commission, New Delhi requesting to take immediate action for review and revision of academic curricula and focus on the existing and potential demand and supply of skill sets to make the University/ College Students employable.

The Board highlighted the fact that courses of some papers of History especially papers related to the study of art, epigraphy and archaeology are oriented in a way to develop field training and skill development in the concerned areas, thus increasing the chances of employability of the candidates. However, an effort will be made to identify more areas for skill development amongst the students.

Agenda Item No. 5: The Board considered the proposals of Sh. Mohan Lal Gupta (MLA), Member Syndicate, referred to the BOS in History vide Syndicate Resolution No. 01 dated 04-02-2017. A copy of this resolution is enclosed herewith for ready reference (See Enclosure 3).

The above mentioned Syndicate Resolution has referred the following proposals of Sh. Mohan Lal Gupta to BOS in History to consider and critically examine these proposals and take appropriate action: -

1. Prof. K. S. Gupta's book on the Battle of Haldighati
2. Shri Onkar Singh Lakhawat's book entitled "Atit se Sakshatkar"

Apart from above, following new topics should also be included in the syllabus:


1. Vanshawali Vidha.
2. Contribution of Swami Shradhhanand and Swami Vivekanand's ideas on cultural nationalism.
3. Contribution of Raja Mansingh of Amber and Raja Raisingh of Bikaner.

The above proposals were discussed at length in the meeting of the board. It was interesting to find that Prof. K. S. Gupta has not written any book on the battle of Haldighati. However, he claims to have written some research papers on Maharana Pratap and the battle of Haldighati.

Similarly, Shri Onkar Singh Lakhawat has not written any book entitled "Atit se Sakshatkar". Shri Onkar Singh Lakhawat has himself written a letter to the Vice Chancellor (copy of letter attached in the set of enclosure 3) stating the fact "that no book entitled as 'Atit se Sakshatkar' is written or edited by him".

It was pointed out to put it on record that Maharana Pratap invariably forms part of the syllabus at UG and PG levels in the papers related to the history of Rajasthan being taught in the University of Rajasthan. As part of the studies on Maharana Pratap, the students do study the narratives on the battle of Haldighati and get acquainted with various versions of the outcome of the battle. However, there is a need to know the latest researches on Maharana Pratap and the battle of Haldighati. The Board was of the view that recent study works on the above theme be included in the list of recommended readings for the students in the concerned paper. Accordingly, the Board recommends the inclusion of the following book in the list of recommended readings in the compulsory paper on the History of Rajasthan being taught in M. A. History Semester II (Paper III HIS 803 : Rajasthan through the Ages) :-

Prof. K. G. Sharma appreciated the fact that Dr. Chandra Shekhar Sharma, in his above mentioned book, has come out with a fresh review and interpretation of Maharana Pratap, projecting him as a great freedom fighter. The book also projects him as a winner in the battle of Haldighati.

Prof. K. G. Sharma suggested that a topic "Debate on the Outcome of the Battle of Haldighati" be included in the syllabus of the above mentioned paper on the History of Rajasthan. His suggestion was accepted by the Board. Accordingly, a revised draft of the syllabus of the Paper III HIS 803 : "Rajasthan through the Ages" of M. A. History Semester II examination was approved and recommended to be put in force w.e.f. the ensuing academic session 2017-18 (Revised draft of the paper is included in the enclosure 2).

As regards the suggestion of Shri Mohan Lal Gupta for inclusion of some new topics in the History syllabi of the University, it was pointed out that the suggested themes form part and parcel of the studies on history in the relevant papers being taught in the University of Rajasthan.

The meeting ended with a vote of thanks to the Chair.


