GUIDELINES FOR NOTICE INVITING E-BIDS

- 1) Head, Department of Botany, University of Rajasthan, Jaipur, invites tenders for the purchase of Equipments under RUSA 2.0 Programme from the competent firm/company who meet the minimum eligibility criteria as specified in this bidding document.
- 2) The complete bidding document has been published on the websites www.eproc.rajasthan.gov.in, www.uniraj.ac.in and <http://sppp.raj.nic.in> for the purpose of downloading.
- 3) Bidders who wish to participate in the bidding process must register on www.eproc.rajasthan.gov.in, www.uniraj.ac.in and <http://sppp.raj.nic.in>.
- 4) To participate in the bidding process, bidders must procure a Digital Signature Certificate (DSC, Type-III) as per Information Technology Act-2000 using which they can sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency viz. TCS, Safecrypt, N Code etc. Bidders, who already have a DSC, need not to apply for a new DSC.
- 5) A single stage one envelope selection procedure will be adopted.
- 6) Bidders (authorized signatory) shall submit their offer online only in Electronic formats both for Technical and Financial Proposals. However, Demand Draft (DD) for Tender Fee, RISL Processing Fee and FMD should be submitted physically at the office of procuring entity as prescribed in NIT and scanned copy of the same should also be uploaded along with the technical bid cover.
- 7) The department will not be responsible for any delay in online submission due to any reason. For this bidders are requested to upload the complete bid well advance in time so as to avoid any technical glitch at the 11th hour.
- 8) Bidders are also advised to refer "Bidders Manual kit" available at e-Proc website for further details regarding e-tendering process.
- 9) Training for the bidders on the usage of e-Tendering System (e-procurement) is being arranged by RISL on regular basis. Bidders interested for training may contact e-Procurement Cell, RISL, Jaipur for booking the training slot. The Help-desk number of RISL is 0141-4022688.
- 10) Only Firms Companies who have participated in EOI, will be permitted to participate in this Tendering process.
- 11) No contractual obligation whatsoever will arise from the RFP/Bidding unless or until and a formal contract is signed and executed between the procuring entity and the successful bidder.


